

DEED OF VARIATION TO THE SUPPLEMENTAL FUNDING AGREEMENT

THIS DEED is made the 29 day of June 2021

BETWEEN

- 1) The Secretary of State for Education (the "**Secretary of State**"); and
- 2) Orchard Hill College Academy Trust, (the "**Company**") a charitable company incorporated in England and Wales with registered number 08476149, together, the "**Parties**".

INTRODUCTION

- A. The Parties entered into a supplemental funding agreement dated 31 March 2016 as varied by a Deed of Variation dated 15 August 2019 (the "**Supplemental Funding Agreement**") relating to the establishment, maintenance and funding of Dysart School (the **Academy**) in accordance with the Supplemental Funding Agreement.
- B. The Parties now wish to vary and amend certain terms and conditions of the Supplemental Funding Agreement in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Supplemental Funding Agreement.

1. INTERPRETATION

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Supplemental Funding Agreement.

2. VARIATION OF THE SUPPLEMENTAL FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from the date of this Deed the Supplemental Funding Agreement shall be amended as follows:
 - 2.1.1 The Summary Sheet on page 4 be amended so that the planned number of places of "125" shall be replaced with "150".
 - 2.1.2 Clause 2.C shall be replaced with the following new clause 2.C:

"2.C With effect from 1 September 2021, the planned number of places at the Academy is 150 places in the age range 4 to 19, including a sixth form of 20 places."
 - 2.1.3 The Summary Sheet on page 4 be amended so that the address of the Land shall be replaced with the following new address of the Land:

"Dysart School, 190 Ewell Road, Surbiton, Kingston upon Thames, KT6 6HL with title number: SGL769063 and Dysart School, School Lane Community Centre, School Lane, Tolworth, Surrey, KT6 7QJ and Dysart School, North Kingston Childrens Centre, Latchmere Road, Kingston upon Thames,

KT2 5TU."

2.2 Except as varied by this Deed, the Supplemental Funding Agreement shall remain in full force and effect.

3. Governing law and jurisdiction

3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.

3.2 The Parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

4. Counterparts

4.1 This Deed may be executed in any number of counterparts and by the Parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
