



Spending Strategy for COVID-19 Catch-Up Premium and DfE Summer School Funding

The COVID-19 Catch-Up Premium was allocated to schools to provide funding to support children and young people to catch up lost time after school closure. Government instructed schools to use this funding for specific activities to support their pupils to catch up for lost teaching and which will help pupils catch up on missed education.

An additional funding stream, the DfE Summer School programme funding, was announced in March 2021 to enable secondary schools to deliver a short summer school, offering a blend of academic learning and enrichment activities.

The following tables outline how these funding streams are being utilised at Dysart to ensure the best possible outcomes for pupils.
